April is Child Abuse Prevention Month. How can we, as CASAs, help PREVENT child abuse? One way is to build protective factors in families. Many families are lacking protective factors -knowledge of parenting, knowledge of child development,

parental resilience, social connections, and concrete supports. Research shows that when parents possess protective factors, the risk for neglect and abuse diminishes and optimal outcomes for children, youth, and families are promoted. These protective factors can help interrupt the cycle of abuse and neglect that many families experience. The Children's Bureau offers a great resource for guiding conversations with parents and caregivers about the protective factors and how parents can care for their children and themselves to create strong families: 2023/2024 Prevention Resource Guide: Chapter 6 Protective Factors Conversation Guides for Partnering With **Families** (childwelfare.gov)

As a Court Appointed Special Advocate, you are a positive, caring adult in the lives of children during what is often a time of turmoil. You provide a voice for children by advocating for their best interests and making recommendations to the court to assist both children and parents. Q & A: Dual Status?

Q: What is Dual Status?

A: Simply stated, Dual Status refers to a youth who has had involvement in both the Family Relations CHINS-Child In Need of Services (JC) Court and the Juvenile Delinquency (JD/JS) Court. There are three different designations:

Dually identified Youth - Youth who are currently involved with the juvenile justice system and have history in the child welfare system but no current involvement (or vice versa)

Dually-Involved Youth – Youth who have concurrent involvement (diversionary, formal, or a combination of the two) with both the juvenile justice and child welfare systems.

Dually-Adjudicated Youth - Youth who are concurrently ad-

judicated in both juvenile justice and child welfare systems (i.e. both delinquent and dependent).

As with all things CHINS, nothing is black and white. As a volunteer, if you have a case involving a dual status child, Suzanne Lange, Assistant Director, is our resident expert and can assist you with questions. In addition, when Suzanne is unavailable, Aaron Reidenbach, CASA Supervisor, can also answer questions. Please know, you will not be alone in working these types of cases, it's just some of you will never have a dual status case. We believe it is more prudent to train volunteers on Dual Status when working on a Dual Status case.
